February 2024

Monday, February 5, 2024 – Regular Council Meeting

Letters of Support from North Huron Council

 Council directed for letters of support to be sent regarding: a social and economic prosperity review, concerns related to the elimination of the license plate renewal fees, the increase to the federal carbon tax, and the Ontario Energy Board's decision on phase 1 of the Enbridge Gas 2024 rebasing application.

Zoning By-law Amendment – Gingerich (38725 Belfast Road)

Council approved of a Zoning By-law Amendment for 38725 Belfast Road, East Wawanosh Ward.
 The purpose of the rezoning is to create a special General Agriculture zone (AG-14) to permit the use of an existing detached accessory building for an additional residential unit.

Adoption of 2024 Municipal Budget

Council adopted the 2024 Municipal Budget at their meeting on February 5, 2024. The budget was
developed through significant discussion and deliberation by Council during several meetings that
included receiving public feedback. The budget includes a total levy increase of 3.8%.

Cross Border Water and Sanitary Sewer Services Agreement – Sepoy Wiring Ltd.

 Council authorized the signing of a cross border water and sanitary sewer services agreement between the Township and Sepoy Wiring Ltd. The Agreement will allow for these services to be extended to the property located at 249 Arthur Street in the Municipality of Morris-Turnberry.

Waste Management Recycling Contract Extension

 Council authorized the execution of a one-year contract extension with Waste Management of Canada Corporation for curbside collection and processing of recyclable materials. The contract will be in place until April 2025.

Transfer of Funds for Community Risk Assessment

 Council directed for the transfer of \$30,000 that were budgeted within the 2023 budget to the 2024 budget for the completion of the Community Risk Assessment. The project is a legislative requirement and began in the fourth quarter of 2023 and is expected to be complete in the second quarter of 2024.

Barn Dance Historical Society – Request for Placement of Plaque in Town Hall Heritage Theatre

Council approved a request from the Barn Dance Historical Society for the placement of a plaque
in the Town Hall Heritage Theatre and directed for staff work with the Barn Dance Historical Society
for the installation of the plaque.

Tuesday, February 20, 2024 – Regular Council Meeting

Appointment of Director of Recreation and Children's Services

• Council appointed Kelly Steiss as the Director of Recreation and Children's Services and welcomed her to her new role with the Township.

Wingham Minor Soccer – Proposal for New Soccer Facilities and Funding Request – Delegation Presentation

Council received a presentation from representatives of Wingham Minor Soccer regarding a
proposal for new soccer facilities in Hutton Heights. Council directed staff to prepare a follow up
report that identifies costs and considers the recommendations of the North Huron Recreation
Master Plan. The report will be brought back at a future meeting for Council's consideration.

Acceptance of Donations and Fundraising Campaigns Policy

Council received an Acceptance of Donations and Fundraising Campaigns Policy and directed staff
to bring forward a by-law for the Policy to be adopted at the March 4th Regular Council Meeting.
This Policy sets out a process for establishing Fundraising Campaigns and establishes methods for
accepting Donations and issuing Income Tax Donation receipts.

Renewal Agreement with Morris-Turnberry for the Maintenance on the Boundary Roads

 Council authorized a five-year renewal agreement for the maintenance on the boundary roads with Morris-Turnberry. The Agreement outlines the shared responsibilities between both municipalities and specifically outlines the impacted roadways.

North Huron Museum Deaccessioning Project – Report #8

 Council received the eighth list of artifacts proposed to be deaccessioned from the North Huron Museum and directed staff to continue with the deaccessioning process for the listed artifacts.

OPP Office Space Request

• At the March 4th meeting, Council decided to proceed with providing the Huron OPP Detachment with office space at the Wingham Fire Hall and for the renovation costs to be funded from the Wingham Only Police Reserve Fund.

Economic Development Officer Position Update

• Council received an update on the Economic Development Officer position investigations and directed for the hiring of a full-time Economic Development Officer for the Township of North Huron.

Belgrave Community Centre Board – Request to Fundraise for Playground Replacement

Council approved the Belgrave Community Centre Board's request to fundraise for the replacement
of the Belgrave Community Centre playground in accordance with the Acceptance of Donations and
Fee Waiving Policy. Council also appointed Councillor van Hittersum as the Council representative
to the Belgrave Community Centre Board Fundraising Subcommittee.

Animal Control By-law Update

Council adopted an updated Animal Control By-law for the Township. The updated by-law reflects
the Township's implementation of DocuPet services for dog tag licensing and improves
enforceability for animal control related issues.
